VIII. New Business

 a. [FOR POSSIBLE ACTION] Allocation of Raising Reser Funds to the Memorial Union

Attached Item: Raising Reser Funds Request; MU ADA Barrier Removal

i. SFC Chair Page: There was a project called Raising Reser between 2005 and 2012 that built one side of Reser Stadium. The SFC gave Athletics a loan of \$2.5 million to help build the stadium, and Athletics has now paid it back with interest. The SFC still has \$133K to dispurse from this. Some of this was allocated to the MU for ADA projects, and they have requested the rest of it for the ADA accessibility at Lanes & Games and a gender-neutral bathroom in the MU.

- ii. **Erica Dodson, Financial Strategic Services:** The MU is asking to repurpose their previously allocated funds towards this project and to have the rest of the Raising Reser funds allocated to them, and this requires a vote of ¾ of the SFC for approval.
- iii. **Canzano** moved to enter into a roll call vote to approve the allocation of the Raising Reser funds to the MU. **Lopez** seconded. There was no opposition.
- iv. The motion passed with 10 in favor and 1 abstaining (Roberts).

IX. Chair Announcements

- Liaisons, please be working with your SABs to find liaisons for next year. Keep SFC Chair Page and the ASOSU President in the loop.
- The SFC at-large elects have been invited to the SFC meetings. There is one open at-large seat for next year so refer anyone you know who might be interested.

- There will be little new business the rest of the term, but liaisons will go over their SAB bylaws with Scrafford, and SFC Chair Page and the at-large members will rewrite the SFC bylaws.
